## VERSION HISTORY

These Terms of Donation were created on the 1st May 2017. Since their creation, there have been no further versions.

From time to time, we may need to make further amendments to Our Terms of Donation due to a change in the website's functionality or the applicable laws. When we do so, we will log the changes above. Nevertheless, please be aware, we will be both bound by the terms stated at the time and date the donation was placed.

## GIFT AID AN TAX RELIEF

---

Please be aware, while we are working to better the world, we are not a registered charity, and as a result, you cannot claim gift aid or tax relief on any donations that you make to us.

## USE OF YOUR DONATION

---

Your donation will help complete the research required to finalise the ZERO-FIFTY, fund the equipment needed to undertake the research, market the ideas contained within ZERO-FIFTY and aid us with printing costs related to the ZERO-FIFTY. It will also help fund our travels to schools, colleges, businesses and universities where we will inform students not only of the damage climate change will bring, but about how this damage can be prevented. Finally, your donation will help us create exhibitions and events related to ZERO-FIFTY that explain both about climate change and how it can be prevented. A small sum, equivalent to 1.4% + 20 pence GBP of your donation for European cards and 2.9% + 20 pence GBP for non-European cards, will also be used to process the transaction.

## PLACING YOUR DONATION

---

Our site will guide you through the process of placing your donation and offer you the opportunity to review and amend your donation before submission. Please ensure that you have checked your donation carefully before making the submission as your payment will automatically be processed.

If you provide us with incorrect or incomplete information, please contact us as soon as possible, and we will do our best to rectify the situation. If we are unable to process your donation due to incorrect or incomplete information, we will contact you to ask to correct it. If you do not give us the accurate or complete information within a reasonable amount of time, we will be forced to cancel your donation.

# CANCELLING YOUR DONATION

---

If you make a donation and change your mind, we can provide you with a full refund for a period of up to 14 days. To do this, simply send us a request by email that includes your name and your donation amount.

If you change your mind after 14 days, you can still send us a request, and in some exceptional circumstances, we may be able to provide you with a partial refund.

Refunds will be issued within ten calendar days of confirmation and made using the same payment method that you used to place the donation.

# DATA STORAGE

---

When you place your donation, we will collect a copy of your name, email address, donation amount, payment information and message along with the time and date that you placed the donation. We may also keep a copy of your postal address. All of this data will be used to process your donation and, if an address has been provided, send you a personalised thank you message. # COMPANY OWNERSHIP

We may transfer our obligations and rights under these Terms of Donation to a third party. This may happen, for example, if we sell our business. If this happens, please rest assured, the new owner will be legally bound to use your donation in full as described in these Terms and Conditions.

You may not transfer your obligations and rights under these Terms of Donation without our express written permission. The contract is between you and us. It is not intended to benefit any other person or third party in any way, and no such person or party will be entitled to enforce any provision of these Terms of Donation.

No failure or delay by us in exercising any of our rights under these Terms of Donation means that we have waived that right, and no waiver by us of a breach of any provision of these Terms of Donation means that we will waive any subsequent breach of the same or any other provision.

# LAW AND JURISDICTION

---

These Terms of Donation, and the relationship between you and us (whether contractual or otherwise), shall be governed by and construed in accordance with English law.

If you are a member of the public, any disputes concerning these Terms of Donation, your relationship with us, or any matters arising therefrom or associated therewith (whether contractual or otherwise) shall be subject to the jurisdiction of the courts of England, Wales, Scotland, or Northern Ireland, as determined by your residency.

If you are a business, any disputes concerning these Terms of Donation, your relationship with us, or any matters arising therefrom or associated therewith (whether contractual or otherwise) shall be subject to the exclusive jurisdiction of the courts of England and Wales.

If any of the provisions of these Terms of Donation are found to be unlawful, invalid or otherwise unenforceable, those provisions shall be deemed severed from these Terms of Donation with the remaining Terms of Donation still valid and enforceable.
